
Open space rough-in design permits new installation or replacement of existing fountains and coolers with this Elkay cooler when rough-in is within the outline shown.

### IMPORTANT! INSTALLER PLEASE NOTE:

This water cooler has been designed and built to provide water to the user which has not been altered by materials in the cooler waterways.

The grounding of electrical equipment such as telephone, computers, etc to water lines is a common procedure. This grounding may be in the building or occur away from the building. This grounding can cause electrical feedback into a water cooler recreating an electrolysis which creates a metallic taste or causes an increase in the metal content of the water. This condition is avoidable by installing the cooler using the proper materials as shown below.

A = Recommended water supply location. Shut off valve (not furnished) to accept

3/8" O.D. unplated copper tube connect. Up to 3" (76mm) maximum out from wall. = Recommended waste outlet location. To accomodate 1-1/4" nominal drain. Drain stub 2" (51mm) out form wall.

C = 1-1/4" Trap (not furnished).

D = Insure proper ventilation by maintaining 6" (152mm) (min.) clearance from cabinet

louvers to wall E = 7/16" (11mm) Bolt holes for fastening to wall.
