

This grounding can cause electrical feedback into a water cooler creating an electrolysis which creates a metallic taste or causes an increase in the metal content of the water. This condition is avoidable by installing the cooler using the proper materials as shown below.


The water cooler must be connected to the water supply using a dielectric coupling The cooler is furnished with a non-metallic strainer which meets this requirement The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.


These products are designed to operate on 20 psi to 105 psi supply line pressure.

A = Recommended water supply location. Shut off valve (not furnished) to accept 3/8" O.D. unplated copper tube connect. Up to 3" (76mm) maximum out from wall. B = Recommended waste outlet location. To accomodate 1-1/4" nominal drain. Drain stub 2" (51mm) out form wall.

C = 1-1/4" Trap (not furnished).

D = Electrical Supply (3) wire recessed box duplex outlet.
E = Insure proper ventilation by maintaining 6" (152mm) (MIN.) clearance from cabinet louvers to wall.

F = 7/16" (11mm) Bolt holes for fastening to wall

NOTE: Nèw installations must use Ground Fault Circuit Interrupter (GFCI). It is highly recommended that the circuit be dedicated and the load protection be sized for 20 amps.
