### IMPORTANT! INSTALLER PLEASE NOTE:


This water cooler has been designed and built to provide water to the user which has not been altered by materials in the cooler waterways.

The grounding of electrical equipment such as telephone, computers, etc to water lines is a common procedure. This grounding may be in the building or occur away from the building. This grounding can cause electrical feedback into a water cooler creating an electrolysis which creates a metallic taste or causes an increase in the metal content of the water. This condition is avoidable by installing the cooler using the proper materials as shown below.

#### NOTICE

The water cooler must be connected to the water supply using a dielectric coupling. The cooler is furnished with a non-metallic strainer which meets this requirement. The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.

These products are designed to operate on 20 psi to 105 psi supply line pressure.



LEGEND

A = Recommended water supply location 3/8" O.D. unplated copper tube connect stub 1-1/2" (38mm) out from wall shut off by others. B = Recommended location for waste outlet 1-1/4" O.D. drain.

C = 1-1/4" Trap not furnished.

D = Electrical outlet location.

E = Insure proper ventilation by maintaining 4" (102mm) (min.) clearance from cabinet louvers to wall. F = Power cord 1-1/2 feet (457mm) long.

G = 5/16" (8mm) screw holes in mounting plate.

NOTE: New installations must use Ground Fault Circuit Interrupter (GFCI)

It is highly recommended that the circuit be dedicated and the load protection be

sized for 20 amps.
