Copper alloy surfaces are for use only in non-food zone areas.

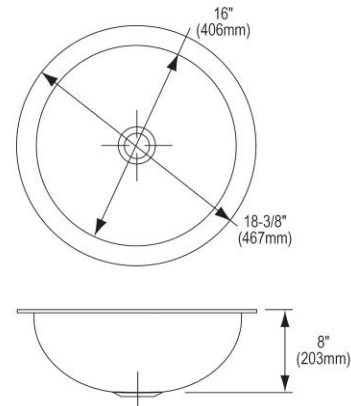

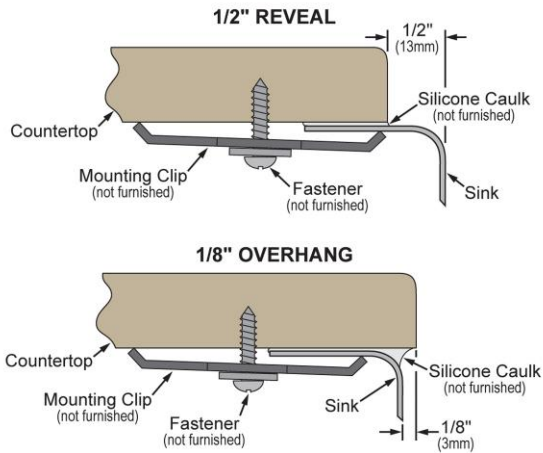
