

REDUCE HEIGHT BY 3 INCHES FOR INSTALLATION OF CHILDRENS ADA COOLER

LEGEND

A = Recommended water supply location. Shut off valve (not furnished) to accept 3/8" O.D. unplated copper tube connect. Up to 3" (76mm) maximum out from wall.

B = Recommended waste outlet location. To accomodate 1-1/2" nominal drain. Drain stub 2" (51mm) out from wall.

C = 1-1/2" Trap (not furnished).


D = Electrical Supply (3) wire recessed box duplex outlet.

E = Insure proper ventilation by maintaining 6" (152mm) (MIN.) clearance from cabinet louvers to wall.


F = 7/16" (11mm) Bolt holes for fastening to wall.

NOTE : New installations must use Ground Fault Circuit Interrupter (GFCI). It is highly recommended that the circuit be dedicated and the load protection be sized for 20 amps.




