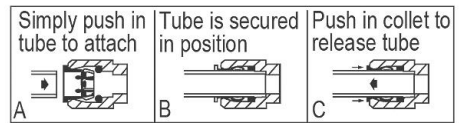

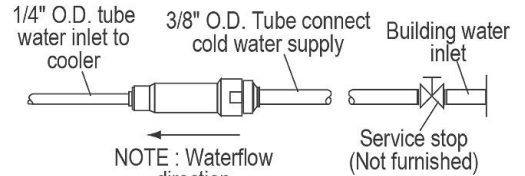

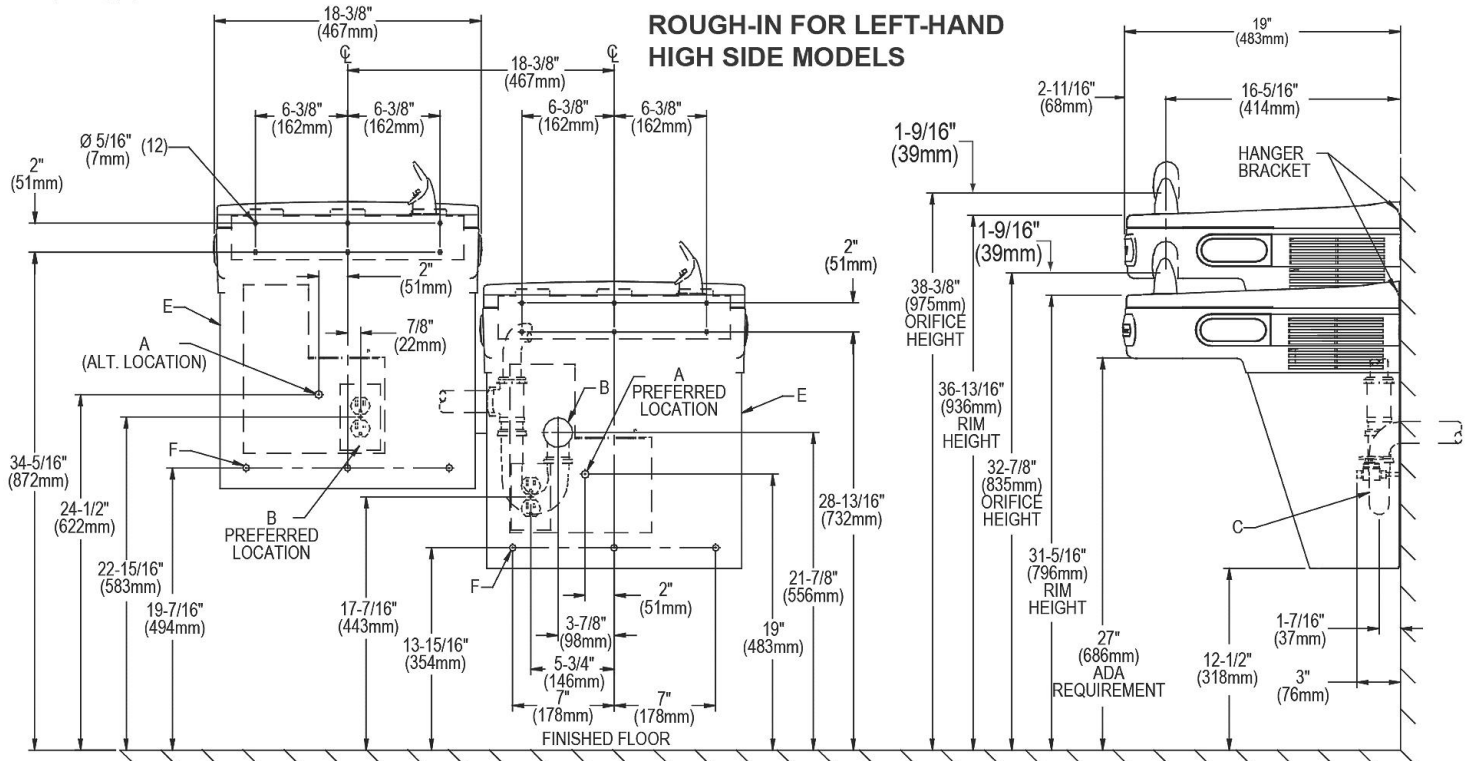
OPERATION OF QUICK CONNECT FITTINGS

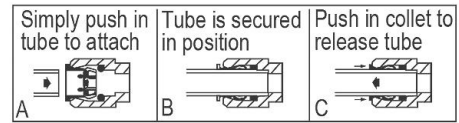

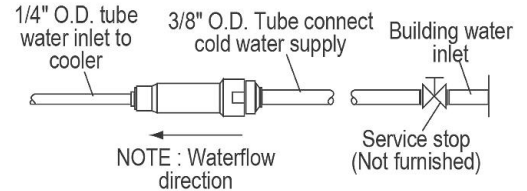

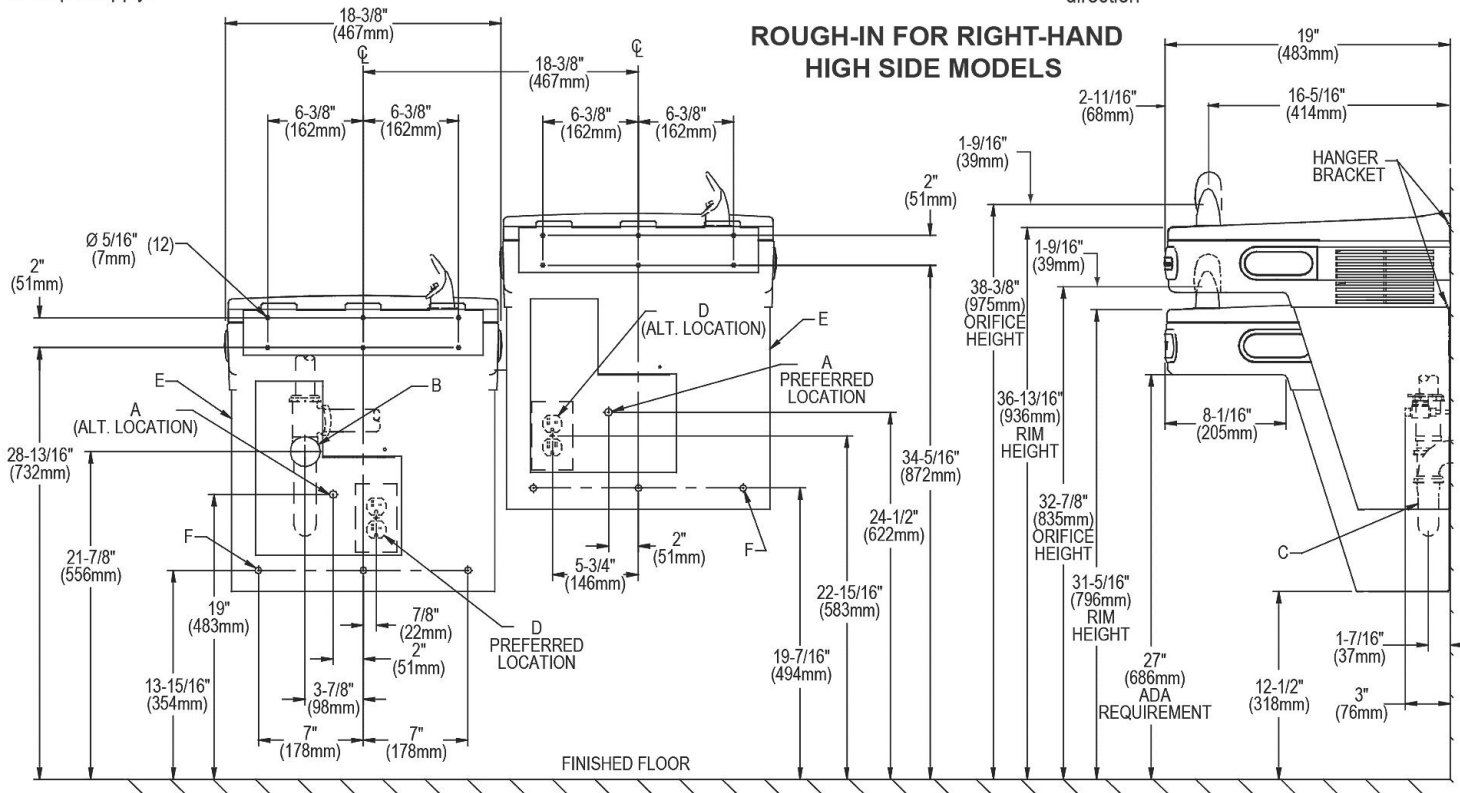
OPERATION OF QUICK CONNECT FITTINGS
