#### LIMITED WARRANTY

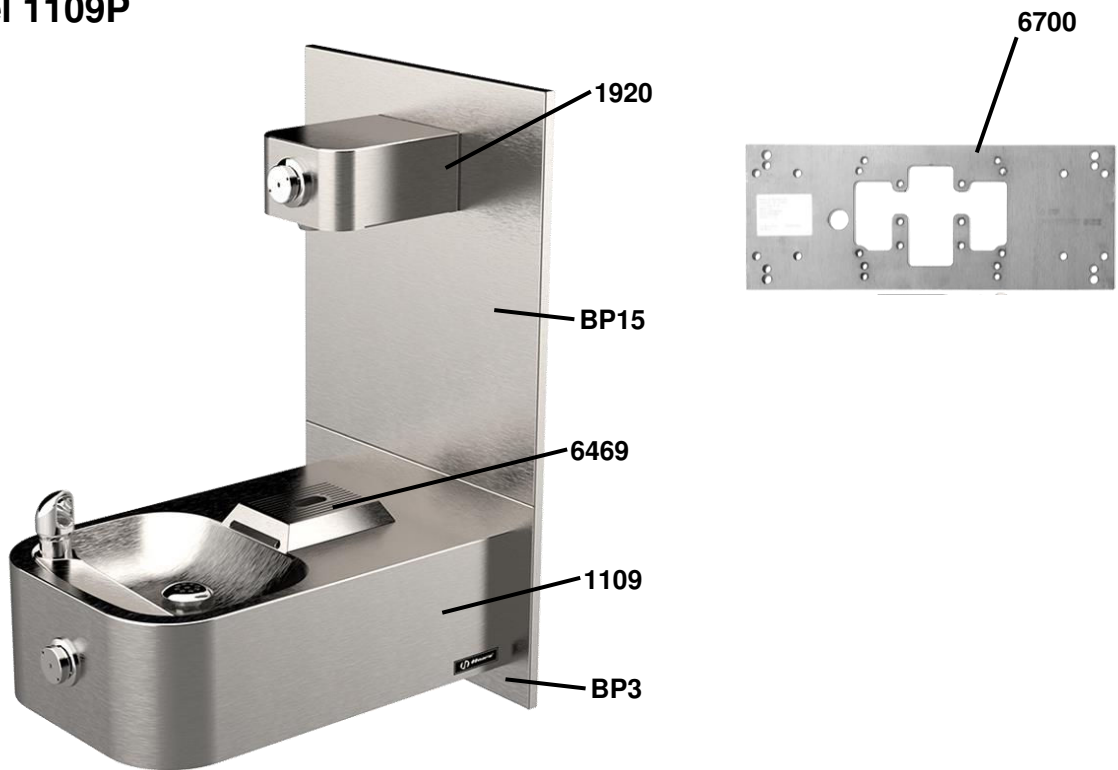

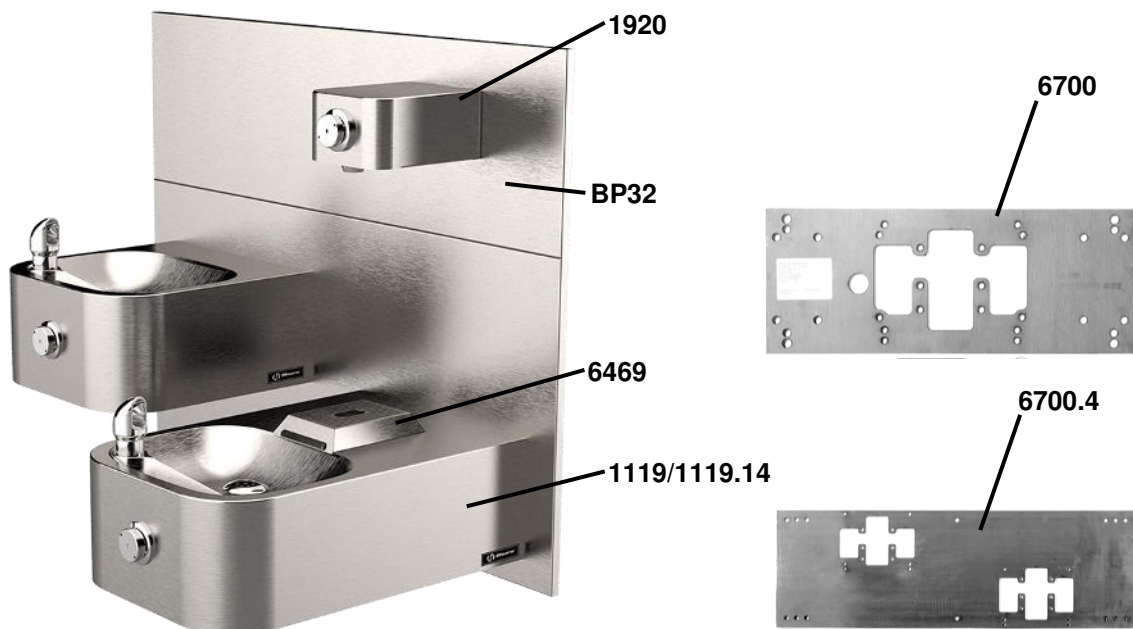

**RECOMMENDED TOOLS:** Hack saw, pipe joint sealant, screwdriver, level, 12" adjustable wrench, 10" pipe wrench, 5/64" hex key wrench, 9/16", 1/2", 7/16" socket wrench or open end wrench, tubing cutter.

**LOCATION OF UNIT:** The Model 1109P/1119P/1119.14P Drinking Fountain is a wheelchair accessible drinking water facility. The height dimensions shown, meet current ADA requirements. When installing this unit, local, state or federal codes should be adhered to. If height other than shown is required, then dimensions must be adjusted accordingly.

**SUPPLY LINE:** The minimum recommended line size is 1/2"IPS with 30-90 psi (2-6 ATM) pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

**PLUMBING CONNECTIONS:** Inlet is 3/8"O.D. push-in type fitting. Waste outlet is female 1-1/4" IPS.

**MAINTENANCE:** Periodically clean the strainer. Refer to 5874 Series Valve Manual for more information.

# **1109P/1119P/1119.14P INSTALLATION PROCEDURE**

**NOTE:** The product manuals included in this bundle contain images and directions for various models and configurations. Please note that not all images and configurations are relevant to this bundle.

**NOTE:** This bundle provides all necessary parts for installation. Models 1119P and 1119.14P have the same installation procedure and are referred to as 1119P below.

Use this manual as a reference for setting up this bundle. Follow the steps below to complete installation.

## **STEP 1: Install Mounting Plates (6700 & 6700.4)**

Model 1109P: Provide a wall opening for two 6700 mounting plates, using the installation instructions located in the 6700 product boxes.

Model 1119P / 1119.14P: Provide a wall opening for a 6700 mounting plate and a 6700.4 mounting plate, using the installation instructions located in the 6700 and 6700.4 product boxes. The 6700.4 mounting plate should be installed below the 6700 mounting plate.

## **STEP 2: Install Back Panel (BP32 or BP15) & Bottle Filler (1920)**

Install the BP32 (or BP15) back panel and the 1920 bottle filler onto the higher 6700, using the installation instructions located in the BP32 (or BP15) and 1920 product boxes.

## **STEP 3: Install Drinking Fountain (1109, 1119, or 1119.14) & Fountain Back Panel (BP3, if included)**

Model 1109P: Install the 1109 drinking fountain with the BP3 back panel to lower mounting plate, using the installation instructions located in the 1109 and BP3 product boxes.

Model 1119P / 1119.14P: Install the 1119 (or 1119.14) drinking fountain (with included back panel) to lower mounting plate, using the installation instructions located in the 1119 (or 1119.14) product boxes.

## **STEP 4: Install Drip Tray (6469)**

Attach the 6469 drip tray to the fountain beneath the bottle filler, using the installation instructions located in the 6469 product box.
