## FEATURES & BENEFITS

#### CONSTRUCTION

Barrier-free design with an 18-gauge Type 304 hi-polished stainless steel swirl bowl assembly mounted on a 14-gauge Type 304 hi-polished stainless steel wall bracket. Unit includes an in-wall mounting frame, and front panel access for P-trap and stop.

### **QUALITY CONTROL**

Pre-built fountain is pressure tested to ensure no leaks and proper functionality.

#### **MOUNTING**

Galvanized frame and 10 gauge surface plate provide the maximum mounting strength for this fountain.

#### **BUBBLER HEAD**

Polished chrome-plated brass bubbler head with integral laminar flow prevents splashing while providing a superior flow pattern. The integral 11/16" dia. basin shank and stainless anti-rotation roll pin for vandal resistance strength. Shielded, angled stream opening provides a steady source of drinking water at .45 gpm.

#### **DRINKING FOUNTAIN VALVE**

The push-button activated valve offers the only all stainless steel valve body that is machined out of solid bar stock, is fully serviceable through the front of the push button assembly offering access to the water control cartridge and integral water supply strainer, and with front access to the water stream height adjustment for easy maintenance without having to remove the valve. Operating pressure range of 30 to 90 psi (2.1 to 6.2 bar).

# VANDAL RESISTANT

The bubbler head, push button, round bowl, drain strainer and bottom plate are locked in place, discouraging unwanted vandal tampering.

## **OPTIONS**

- Remote Drinking Fountain Water chiller: Model HCR8, 8 gph (30.3 L) remote water chiller provides instantaneous cooling to meet a continuous demand for chilled water.
- High Polished Bottle Filler: Model 1920HPS, polished stainless steel bottle filler can be a stand-alone station, or mounted above Haws 1001HPS and 1011HPS series drinking fountain models.
- Back Panel: Model BP15HPS, polished stainless steel 15" back panel for Model 1920HPS.
- Water Filter: Model 6426, 10" x 2" (25.4 x 5.1 cm), in-line lead removal element that reduces lead from incoming water supply.

(3.2 cm) waste pipe.
