CONSTRUCTION

Barrier-free designed fountain for child or adult ADA access. Made of air-entrained concrete with exposed aggregate finish and galvanized wire. Air entrainment ensures strength and freeze-thaw durability. Unit has a stainless steel basin, and hood extension to protect the bubbler head with a partial enclosure. Vandal-resistant bottom plate, and chrome-plated 1-1/2" (3.81 cm) IPS trap.

DRAIN CLEAN-OUT

Top-down access to the drain allows the fountain portion to be cleaned without taking the unit apart, good for outdoor settings with drain-clogging sediment such as leaves, garbage, and other debris.

BARRIER FREE

Designed for Adult or Child ADA access, the spacious fountain design allows for the trap to be internally mounted which allows for easy access.

MOUNTING

3/16" (.47 cm) steel mounting plate (sold separately) with supplied mounting hardware for a solid unit base allows for easy installation to a framed wall.

BUBBLER HEAD

Polished chrome-plated brass bubbler head with integral basin shank for added strength. Shielded, angled stream opening provides a steady, sanitary source of drinking water at .45 gpm.

DRINKING FOUNTAIN VALVE

The push-button activated valve offers the only all stainless steel valve body that is machined out of solid bar stock, is fully serviceable through the front of the push button assembly offering access to the water control cartridge and integral water supply strainer, and with front access to the water stream height adjustment for easy maintenance without having to remove the valve. Operating pressure range of 30 to 90 psi (2.1 to 6.2 bar).

VANDAL RESISTANT

The bubbler head, push button, drain strainer and bottom plate are locked in place, discouraging unwanted vandal tampering.

1. HOLD ROUGH-IN DIMENSIONS $\pm 1/4"$ (6.4mm).
2. WHEN INSTALLING THIS UNIT, LOCAL, STATE OR FEDERAL CODES SHOULD BE ADHERED TO. FOR INSTALLATION HEIGHTS OTHER THAN SHOWN, DIMENSIONS MARKED (*) MUST BE ADJUSTED ACCORDINGLY.
3. **PROCEDURE FOR ASSEMBLING ARM TO WALL:**
IMPORTANT: L-BRACKETS ARE PRE-ASSEMBLED AND **MUST NOT** BE LOOSENER FOR ANY REASON.
STEP 1: ATTACH ENTIRE ARM ASSEMBLY TO WALL USING 6700 MOUNTING PLATE (SUPPLIED) USING THE 3/8"-16 X 4" THREADED RODS, WASHERS AND NUTS (SUPPLIED WITH 6700 MTG PLT) AND TIGHTEN SECURELY IN PLACE.
STEP 2: (OPTIONAL) APPLY CAULKING AS NEEDED TO FILL ANY GAP PRESENT BETWEEN ARM AND PEDESTAL.
4. REFER TO 5874 SERIES OPERATION AND MAINTENANCE MANUAL FOR PUSH BUTTON AND VALVE INSTALLATION/MAINTENANCE INSTRUCTIONS.
