Bubbler shall be polished stainless steel with a non-squirt feature and operate on water pressure range of 20 - 105 psig. Fountain is certified to ANSI A117.1, Public Law 111-380 (NO-LEAD), CHSC 116875 and NSF/ANSI 61, Section 9. Fixture meets ADA, ADA Standing Person, and ADA Child requirements when mounted appropriately.


