## MODEL PGFSBF-BRB-FRX

### Suggested Specification

Model PGFSBF-BRB-FRX is a non-refrigerated fountain and delivers ambient water. Shall include PG8AC and the VersaFiller Bottle Filler with independent push button manual activation; lower unit shall have four push pads to activate the manual flow of water for the cooler. Bottle Filler alcove and cabinet finish shall be stainless steel. Key VersaFiller components contain Freshield®, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew. Basin shall be designed to eliminate splashing and standing water. Water saver bubbler reduces waste water by 50% and shall operate between 20 and 100 PSI. One-piece low flow vandal resistant chrome plated solid construction metal bubbler keyed into place to prevent vandalism. Cabinet finish shall be brushed stainless steel. Shall comply with ANSI 117.1 and ADA. Shall be listed by Underwriters Laboratories to US and Canadian standards. Shall comply with NSF/ANSI 61 and NSF/ANSI 372.

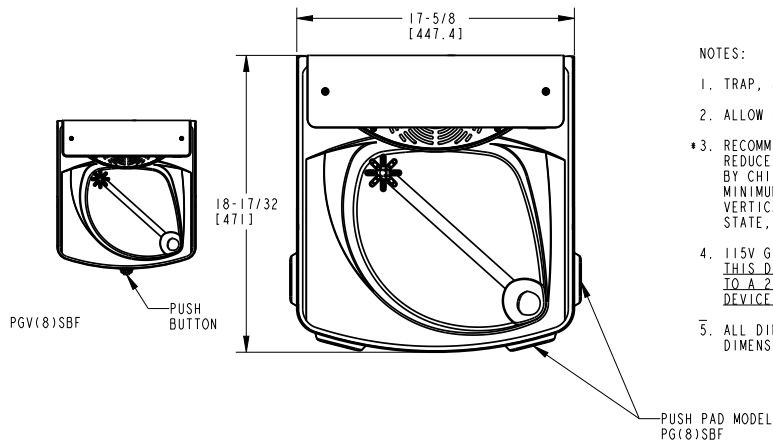
