

ADAF8AC, ADAFAC

Suggested Specification

Model ADAF8AC shall deliver 8.0 gph of 50° F degree water at 90° F ambient and 80° F inlet water. Model ADAFAC is a non-refrigerated drinking fountain and delivers ambient water. Shall have Oasis Green Filtration System for taste, odor, lead, and chlorine reduction. Green Filter shall be biodegradable. Models ADAF8AC and ADAFAC shall include front and side push pads to activate the flow of water. Basin shall be designed to eliminate splashing and standing water. Bubbler shall have flexible guard and operate between 20 and 120 PSI. Cabinet finish shall be Sandstone or Greystone powder coated paint on galvanized steel or brushed stainless steel. Cooling system shall use R-134a refrigerant. Shall comply with ANSI A117.1 and ADA. Shall be listed by Underwriters' Laboratories to U.S. and Canadian standards. Shall comply with ANSI/NSF 61.

Models

ADAF8AC Delivers 8.0 gallons of chilled drinking water per hour. **ADAFAC** is a non-refrigerated fountain. These models satisfy CABO/ANSI A117.1 and these water coolers comply with ADA requirements when properly installed. Models also meet guidelines for children's accessibility providing the floor to orifice height is 30 inches and proper clear floor space is provided for frontal approach.

- > Built-in 100 micron strainer stops particles before they enter the waterway
- > Product Certified by NSF to NSF/ANSI Standard 61, including Annex G, (AB953); except for the Green Filter System, which has been tested by independent laboratories to the NSF Standard 42, and 53, but not certified by NSF
- > Waterways are Lead-Free In Materials & Construction

Powder Coated Finish Warranty (Continental limits of the United States and Canada): Three years on the powder coat finish provided that the water cooler has not been subjected to abuse, misuse, or alteration.

Limited 5-Year Warranty (Continental limits of the United States and Canada): Five years on the sealed refrigeration system and most component parts. Detailed warranty certificate enclosed with each water cooler; sample available upon request.

Export Warranty: One year on component parts. Detailed warranty certificate enclosed with each drinking fountain; sample copy available upon request.

Models covered by this specification comply with all known Plumbing Codes. Listed by Underwriters' Laboratories to U.S. and Canadian standards.


